Statement

Investors overseas who want to earn passive income from U.S. real estate and technology driven mobility markets face significant barriers. While some platforms (e.g., Lofty) offer fractional investment in U.S. properties, these existing solutions often fall short due to trust and centralization concerns. Investors must rely on a central authority to manage their assets, which leads to worries about transparency, security, and potential mismanagement.

This situation highlights the need for a secure, transparent, and regulatory-compliant investment framework tailored for overseas investors. Uzay Foundation aims to fill this gap by creating a platform that minimizes the need for blind trust through enhanced transparency and robust security measures, all while fully adhering to U.S. regulations. Crucially, Uzay will navigate U.S. regulatory requirements and leverage provisions like the SEC's Rule 506(c) exemption for accredited investor offerings. This compliance-first approach ensures that investors from anywhere in the world can legally and confidently access U.S. real estate and tech opportunities for passive income.

Uzay Foundation is building a secure, transparent, and regulatory-compliant platform designed to bridge overseas investors with U.S. real estate and technology-driven mobility markets. Our mission is to eliminate traditional investment barriers by leveraging blockchain technology while adhering to rigorous regulatory standards. This briefing outlines our funding strategy, investor terms, use of funds, governance framework, and early pilot achievements.

Funding Structure & Regulatory Framework

Funding Rounds

• Pre-Seed & Seed Rounds:

- Regulatory Basis: We will utilize Rule 506(b) or 506(c) of Regulation D for our Pre-Seed and Seed rounds. These exemptions allow us to raise capital from accredited investors while ensuring full regulatory compliance.

• Public Sale:

- Regulatory Basis: The public token sale will be conducted under Regulation S, enabling participation from non-U.S. investors and expanding our global investor base.

Use of Funds

• Pre-Seed Funds:

- These funds will be used to incorporate the foundation and develop our Minimum Viable Product (MVP). This phase will focus on laying the technical and operational groundwork to ensure a robust platform launch.

• Seed Funds:

- Funds raised in the Seed round will be allocated to scaling our technology platform and acquiring initial real-world assets (such as vehicles and properties) to underpin our asset-backed investment model.

Technology & Security

• Smart Contract Audits:

- Our smart contracts will be audited by some of the most trusted audit firms in the industry. These rigorous audits will ensure that our token distribution, governance modules, and overall platform operations are secure and transparent.

Investor Access & Governance

Investor Dashboard:

- All investors will gain access to a dedicated investor dashboard, which will provide regular updates on project progress, financial performance, and key milestones. This dashboard ensures complete transparency and real-time insights into the project's development.

• Governance Participation:

- Both investors and members of our Advisory Board will have voting rights on critical project developments. This means you can actively participate in decision-making processes, ensuring that your interests are represented at every step of our growth journey.

Pilot Project & Early Achievements

• Pilot Project:

- We've secured 12 investors for Uzay Auto's pilot project – executed without a full-scale MVP using no-code solutions.

• Fundraising & Sales:

- We raised \$50K and successfully fractionalized the sale of one Tesla Model 3 and one Tesla Model Y as part of the pilot.

• Revenue & Returns:

- The vehicles are now generating rental income, with our investors already seeing \$2,140 in returns after the first 30 days. In addition, Uzay Auto recorded a return of \$418 in the first 30 days.

• Future Plans:

- We're preparing to launch our first NFT collection for Uzay Auto, which will serve as the MVP for Uzay Foundation's mobility chapter.
